<u>Information re Certain Subscription Categories</u>

- *Members in the following categories -AIC/BIC, A2/B2, A3/B3 & A3a/B3a are entitled to a membership subscription reduction when the following conditions are fulfilled.
- 1). The member must have 15 years of continuous membership of Baltinglass Golf Club.
- 2). The age category must be achieved by December 31st of the previous year. (e.g. members whose 71st or 76th birthdays are in January or later they do not qualify for the reduced membership subscription until the following year).
- *A1C/B1C Ordinary Membership (Partner an A1/B1 Member). If one (1) member is receiving a membership subscription reduction as per A2/B2, A3/B3 & A3a/B3a, the other partner **does not qualify** for a subscription reduction.
- *A5/B5 (Under 35 years) The age category must be achieved by December 31st of the qualifying year. One must still be 35 years of age as of December 31st to qualify. Any member whose 36th birthday is in January or later, does not qualify for this category of membership.
- * D1/D2 Student/Apprentice Membership. (Those attending any recognised Third Level Educational Institution). Members in this category will be required to provide certification of their eligibility annually. Such membership shall cease on the 1st January following graduation or qualification or on the 1st January, following their 26th birthday.

Baltinglass Golf Club Membership Subscription 2024

<u>All Club Members</u>, including Honorary, Life Honorary and any Dual Club members, whose handicap is governed by Baltinglass Golf Club, must pay the Golf Ireland annual fee of €28 (for 2024) to Baltinglass Golf Club.

Members whose subscription payments do not match with our records, will be contacted. A certification of one's date of birth may be requested to qualify for these membership reductions.

Golf Club Vouchers may be used as part payment of the annual subscription.

The Club's Constitution States:

The Club year starts on the 1st of January each year. Subscriptions decided at the Annual General Meeting are payable on the 1st of January. Payment for the full amount is determined at the aforementioned meeting. After the 31st January each year, members whose subscriptions for the current year remain unpaid, or have not signed an arrangement for payment by standing order, shall be ineligible for any competition prize, or to represent The Club until all liabilities have been discharged, nor shall members in arrears be entitled to vote at any meeting of The Management Committee or Club Sections.

Payment by standing order is by prior agreement of the Club's Honorary Treasurer. Payments by standing order in equal amounts, must be processed by the 30th of each month. Full liabilities, for those paying by standing order, must be discharged by the 30th June. Any member, paying by standing order who has not discharged his/her liability by 30th June, will have his/her membership suspended until all liabilities are discharged.
